- 2. Review previous meeting's minutes: Motion made by Alex and seconded by Nike passed to approve the March 13, 2024 minutes. Motion made by Alex and seconded by Upendra passed to approve the April 10, 2024)

In response to the question if our landscaping service was responsible for reducing the presence of stagnant water in the woods behind Cambridge Court, the Board noted that this was not the responsibility of the landscaping service, but that this concern could be addressed separately as a drainage project.
 - b. A resident expressed concern that the edge of the woods behind Wyndham Court is encroaching on the lawn behind Wyndham Court.
 - c. The residents at 54 Somerset Court asked the Board to check three trees located adjacent to their property and potentially in common ground.
 - d. A resident expressed concern regarding a tree branch that might extend over the chimney at 12 Wyndham Court.
